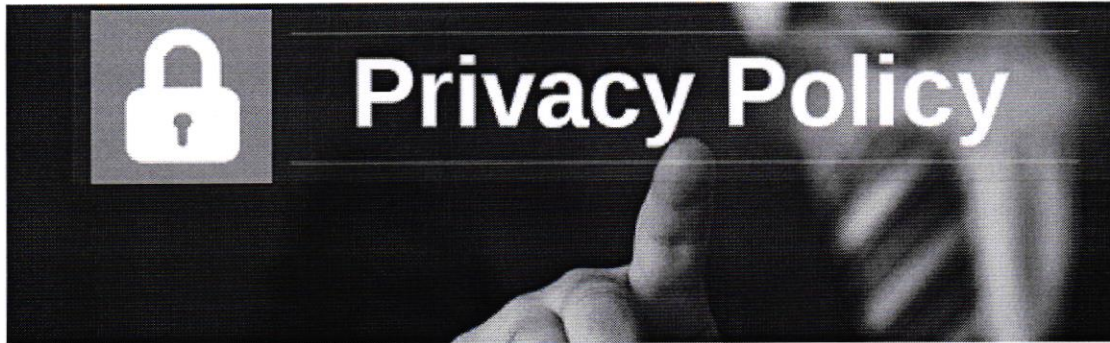


## Bank Privacy Policy for
